

“IMAGINE”
TRANSITION NELSON –ORIGINAL ART- CONTEST-
PEOPLE’S CHOICE- ENTRY FORM

PRIZE MONEY: 1ST PLACE- \$500; 2ND PLACE- \$350; 3RD PLACE -\$200

THEME: An original art work, including sculpture, painting, photo or poster inspired by a vision of how Nelson can transition to a sustainable future.

Contest Rules and Regulations

1. Photos or a video of potential submissions should be submitted on a **DVD** to the Transition Nelson Society (“Transition Nelson”). Please use a regular-size DVD case (not the ultra thin kind) and label the spine with your name. (Make sure your name is also written directly on the DVD.)
2. Each submission must be accompanied by a **completed Official Entry Form**.
3. The contest is open to all ages. However, if a person is under 19 years of age, a parent or guardian of the person must sign the Official Entry Form as well.
4. If other copyright, including, for example, stock photo material, is used in the submission then the artist must purchase all necessary permissions, waivers or rights to incorporate such materials, and for copies to be made and used for the presentation of the material to the judges and public at the Imagine event.
5. The submissions should not contain any unlawful, defamatory or illegal content.
6. If requested the artist will supply Transition Nelson with proof that he or she has satisfied the requirements of these rules and regulations.
7. The artist agrees that Transition Nelson may use any images of the art entered in the competition for publicity purposes and that any such use of these images by Transition Nelson, its agents, licensees or assigns, will not be construed as a breach of the artist’s copyright or other moral rights.
8. Transition Nelson will select the panel of judges to preselect the art work for display at the Imagine Nelson event. The winning artistic works at the Imagine Nelson event will be chosen by the audience. The decision of the judges and the audience will be final.

9. Artists of preselected artwork will be invited to display their art works at the Oxygen Centre located at #3- 320 Vernon St. (alley entrance) Nelson, B.C. on the weekend of April 17th, and 18th, 2010. Works will be set up for public display between 9 a.m. and 11 a.m. on Saturday April 17th.

10. The public that attends the Oxygen Center during the Saturday, April 17th and Sunday, April 18th will be asked to vote on their favourite art works. Voting closes at 4:30 p.m. on Sunday, April 18th. A wine and cheese party will be held at 5:30 p.m. at the gallery and cash prizes and commemorative awards, "Seedlings", will be awarded immediately after the enumeration of ballots received from the public.

Each art work entered into the Contest must be accompanied by an entry form, completed by the person making the submission. This person will be considered the "Artist" of the artwork. Multiple entries will be accepted. Please ensure separate entry forms are completed for each entry.

I will indemnify and hold harmless Transition Nelson its officers and directors in respect of any expense, cost, action or claim brought based on an allegation that any use of the art work or images of the art work by Transition Nelson violates (a) any of the Contest Rules and Regulations, (b) any of my warranties, or (c) any right of a third party. I will cooperate in the defence of any such claim and will provide such evidence, including attendance in person, as Transition Nelson may require.

For good and valuable consideration, I hereby agree that Transition Nelson, its agents, licensees and assigns, may use any images of my art work entered in the competition for publicity purposes and that any such use of images of my art work by Transition Nelson, its agents, licensees and assigns, will not be construed as a breach of the my copyright in respect to the art work submitted, which I warrant was created by me. For this purpose, I waive any copyright or other moral right in respect to the original art work in favour of Transition Nelson and its agents, licensees and assigns.
